Register [HERE](#) and then click on each individual topic and register there as well. This link will register you with GoToWebinar and provide access for the entire day of activities.

Q. How do I register?

Q. How do I get credit?

Q. Do I need to do that for each presentation I was to attend?

A. Yes, if you want credit for the presentation.
